*A report can be obtained at your cost from your local police department or the Louisiana Bureau of Investigation. The report will be kept in a strict, confidential file.*

- District 3: Terrebonne Parish – Theriot/Lower Dularge (70397) and Dulac (70353)
- District 4: Terrebonne Parish – The area of Houma (70363) south of Thompson Road along Hwy. 57 (Grand Caillou Road) and Hwy. 315 (Bayou Dularge Road) south of the Intracoastal Canal
- District 5: Terrebonne Parish – The area of Houma (70363) north of Thompson Road along Hwy. 57 (Grand Caillou Road) and Hwy. 315 (Bayou Duarge Road) north of the Intracoastal Canal including all of East Houma, Village East, etc.
- District 6: Terrebonne Parish – Houma (70364 & 70360), Gibson (70356), Gray (70359) and Schriever (70395)
- District 7: All of Plaquemines and St. Bernard Parishes, Jefferson Parish – Gretna (7005370056)
